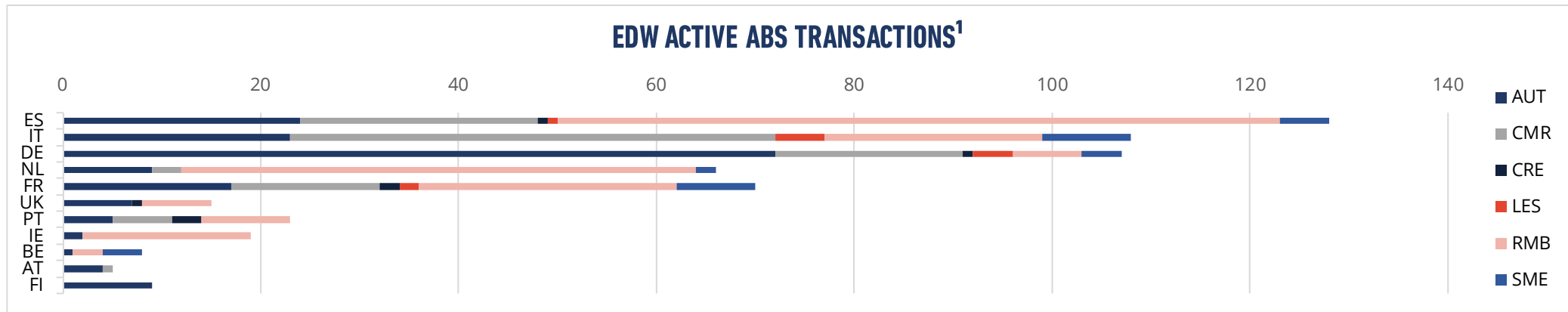
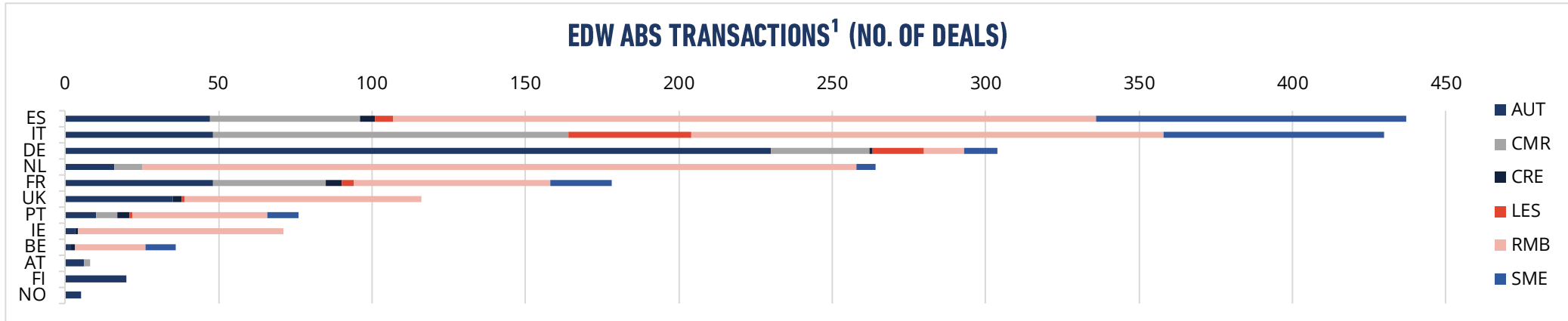
# DATASET COMPOSITION AS OF 31 MAY 2026
