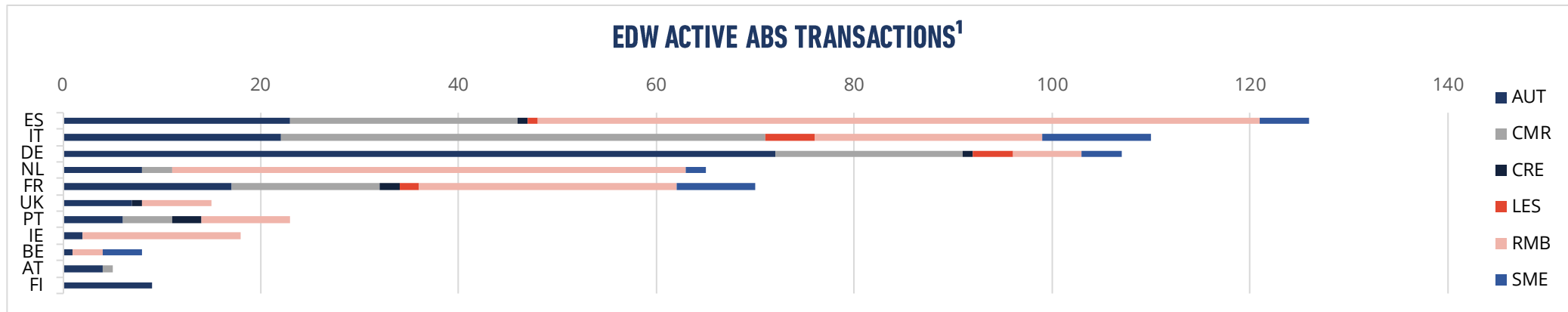
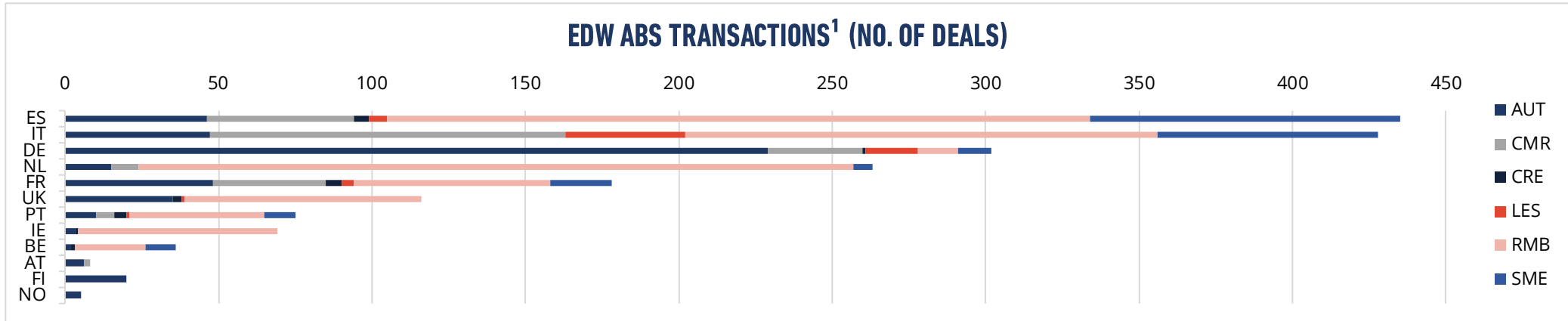
DATASET COMPOSITION AS OF 30 APRIL 2026
