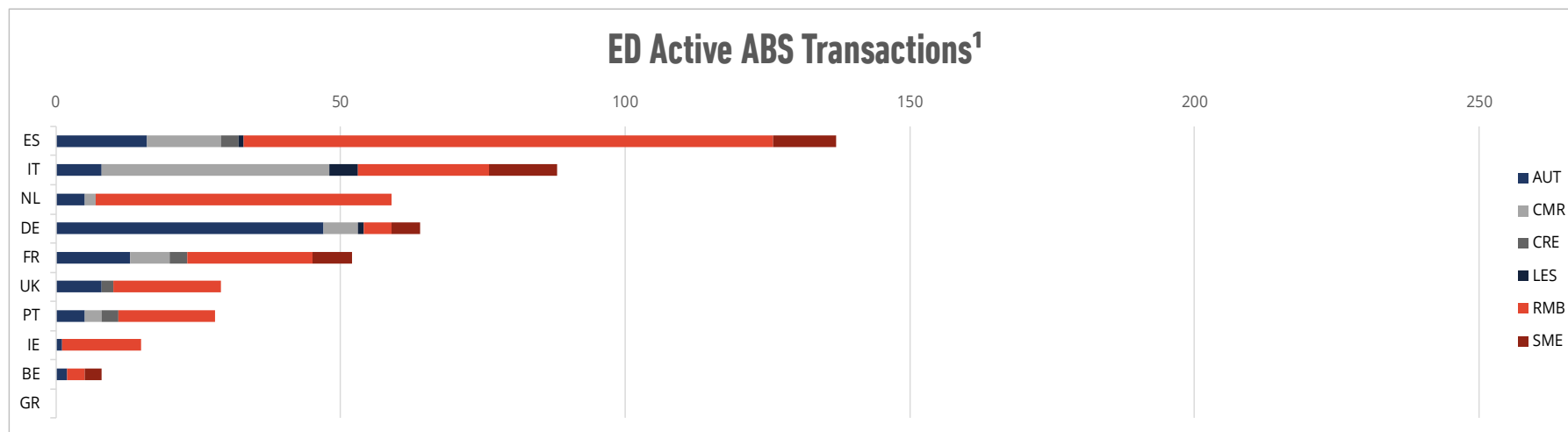
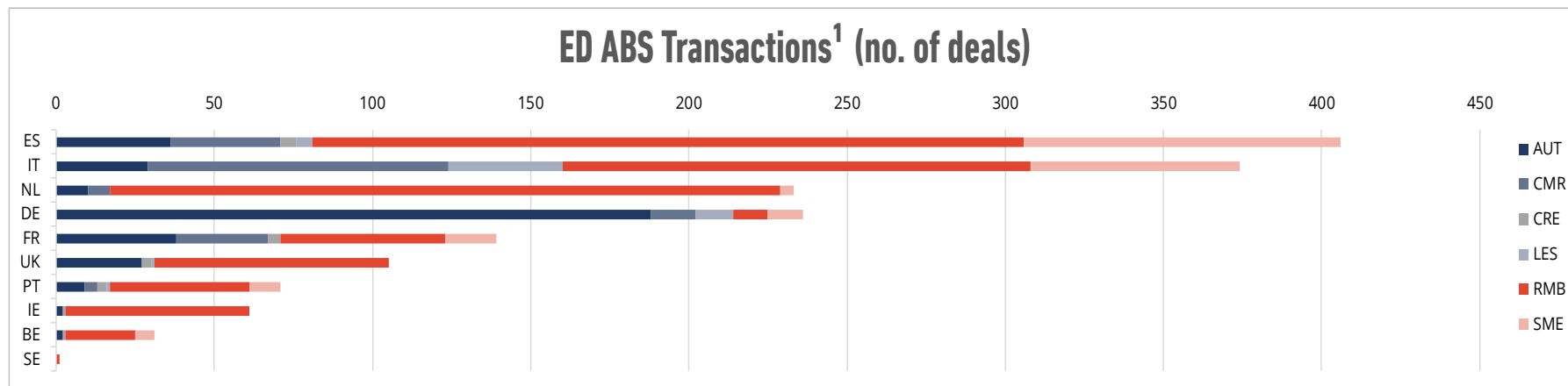


# DATASET COMPOSITION AS OF 30 SEP 2024

# DATASET COMPOSITION AS OF 30 SEP 2024

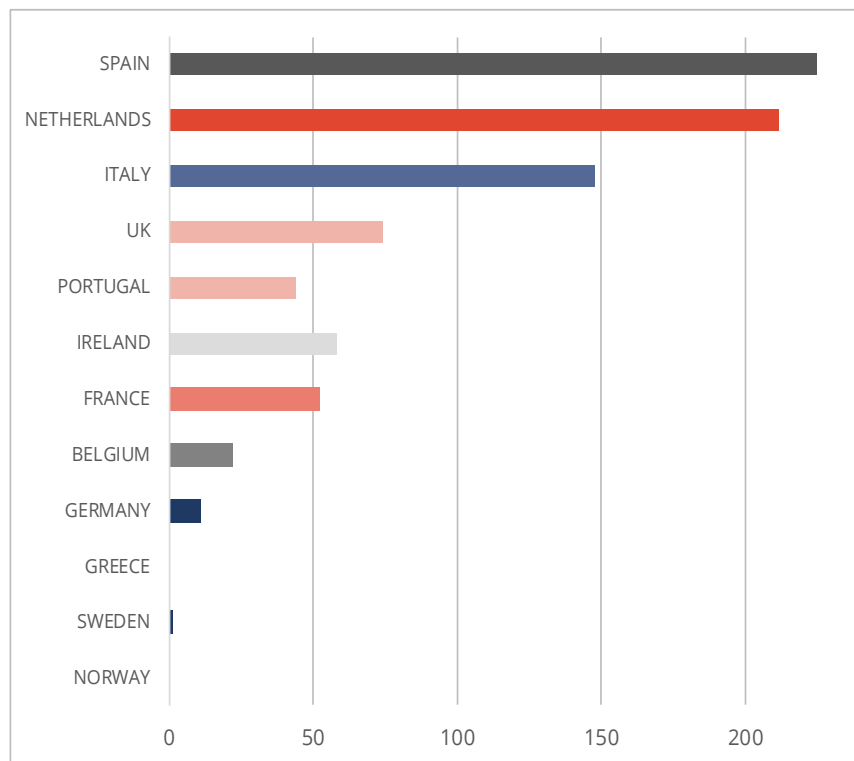

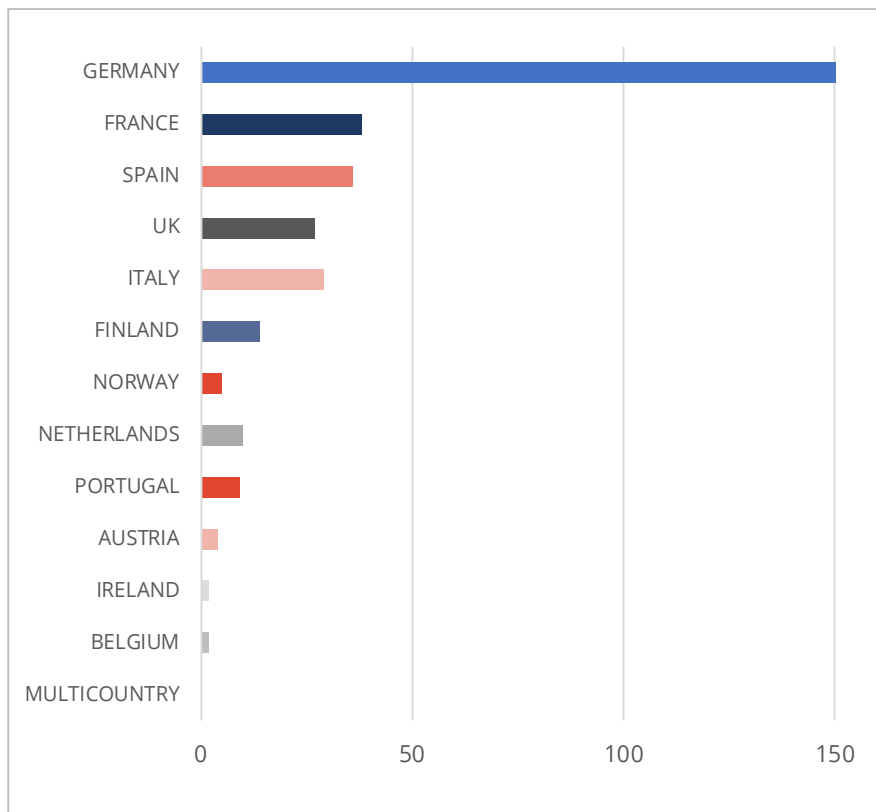

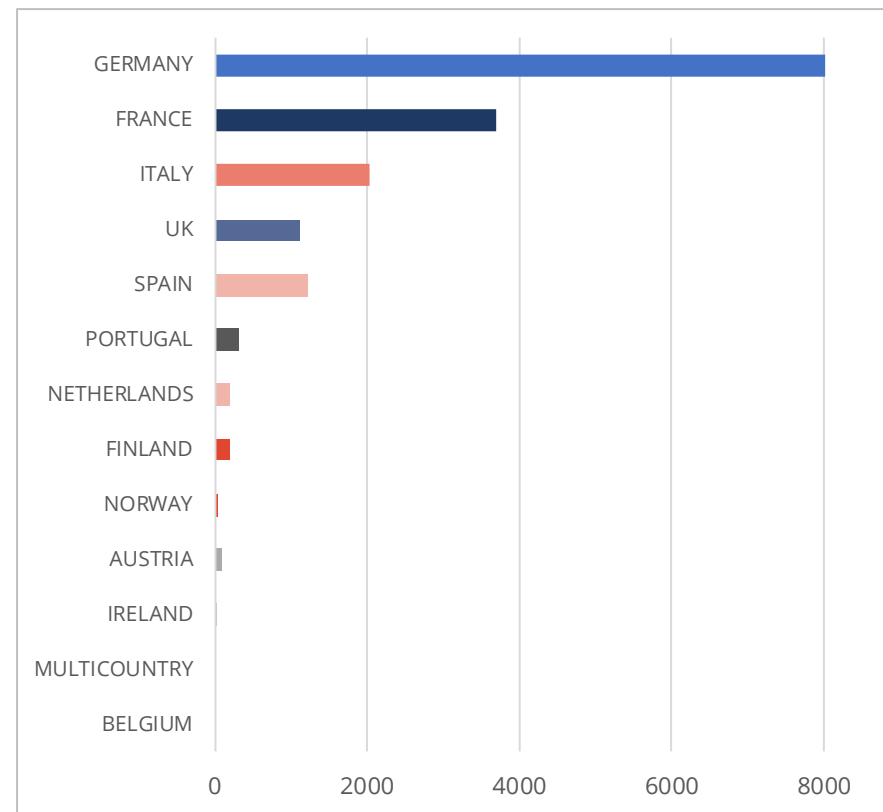

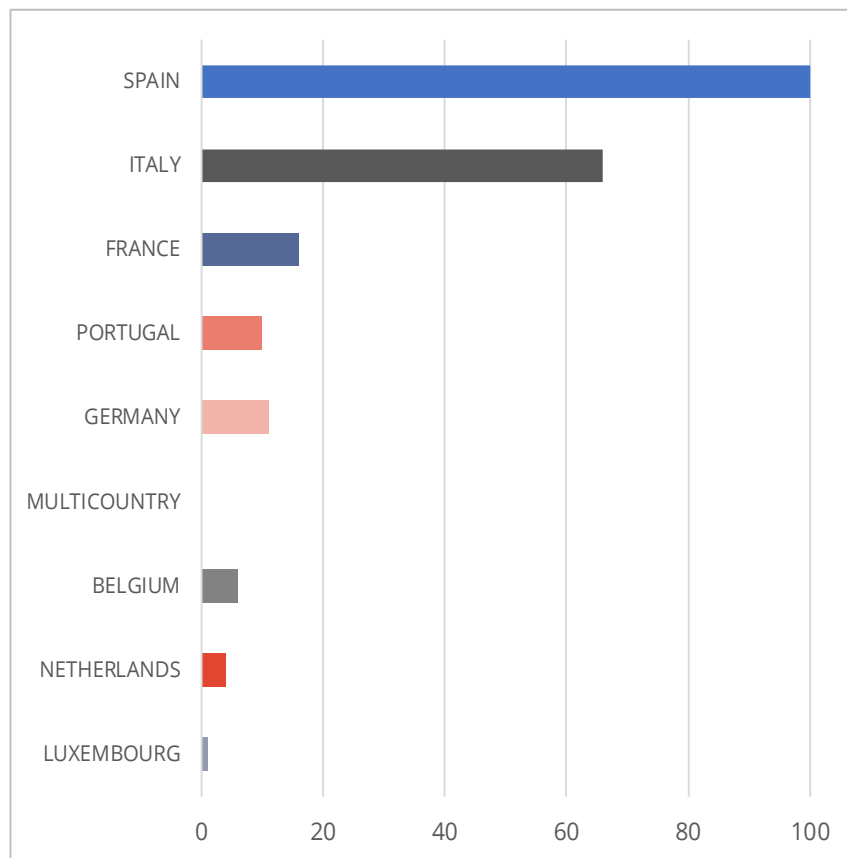

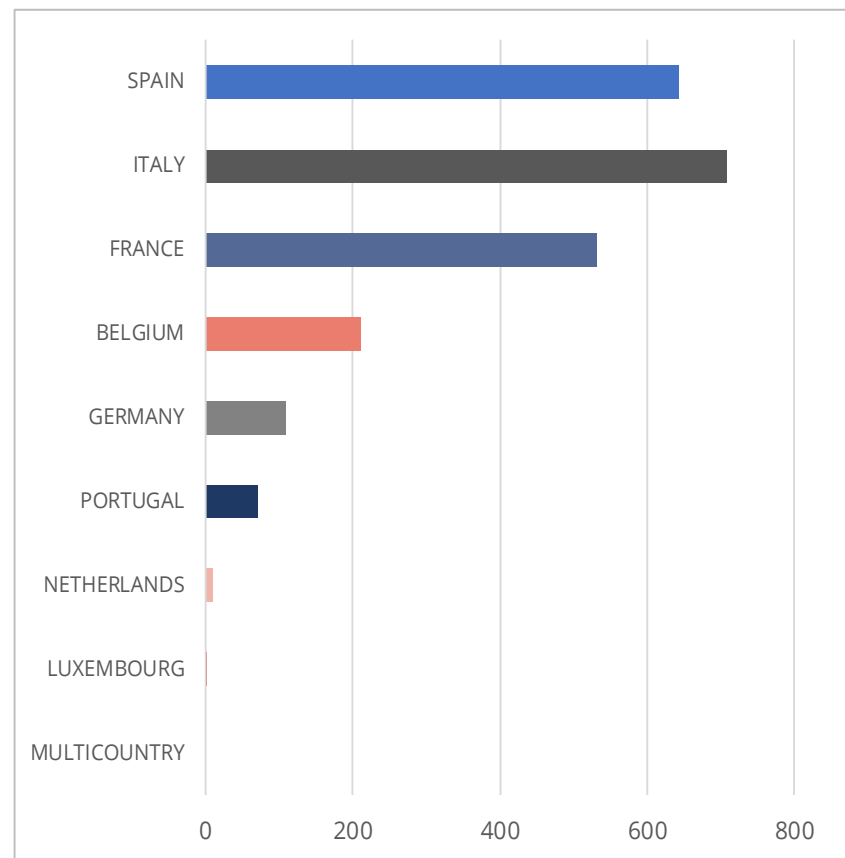

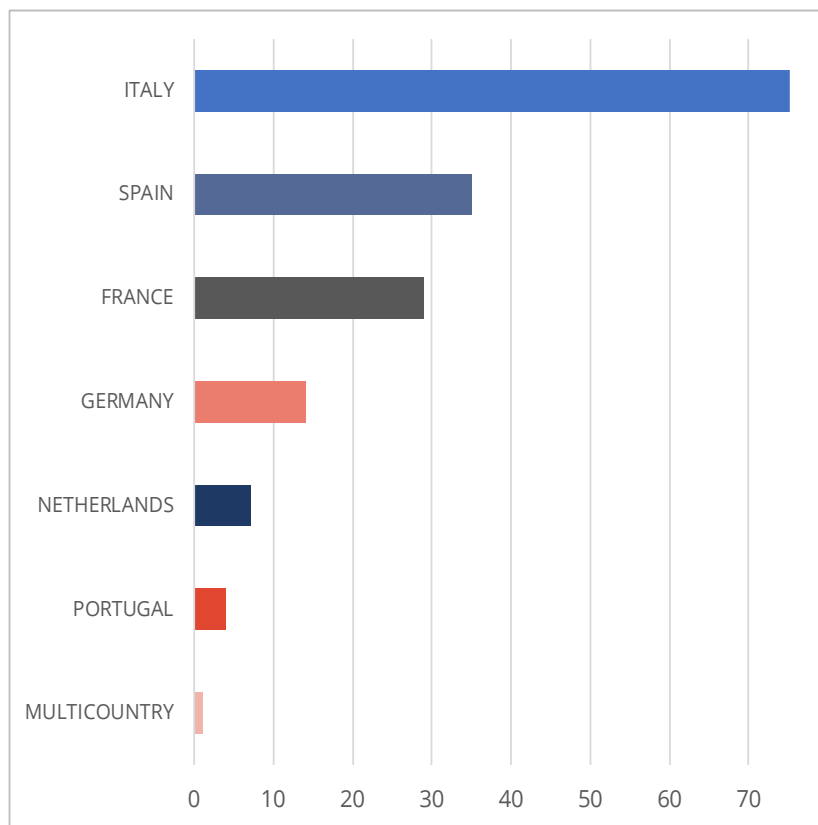

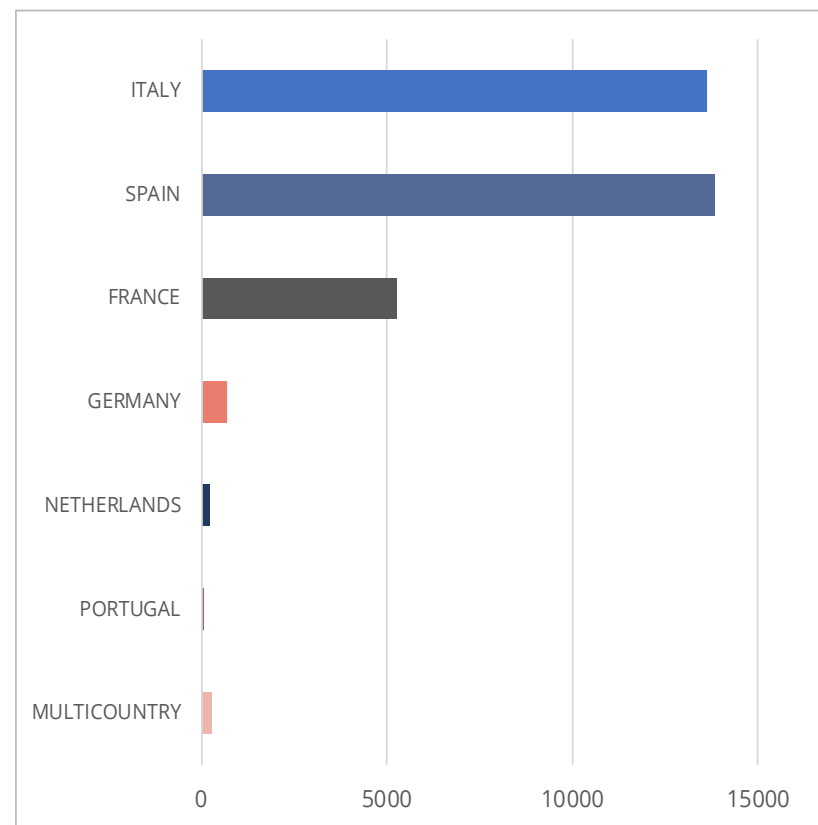

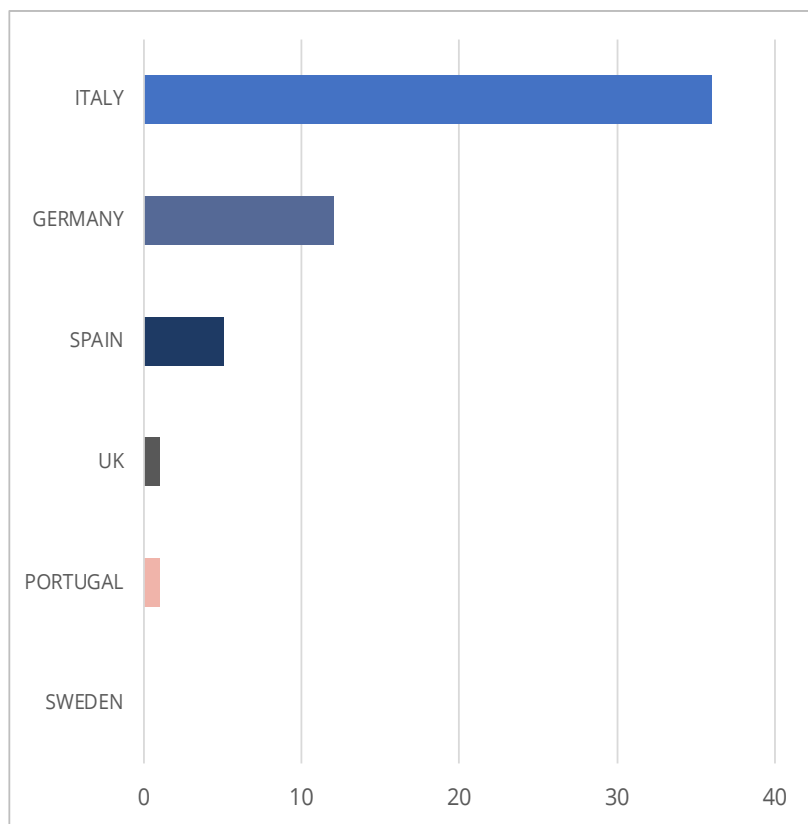

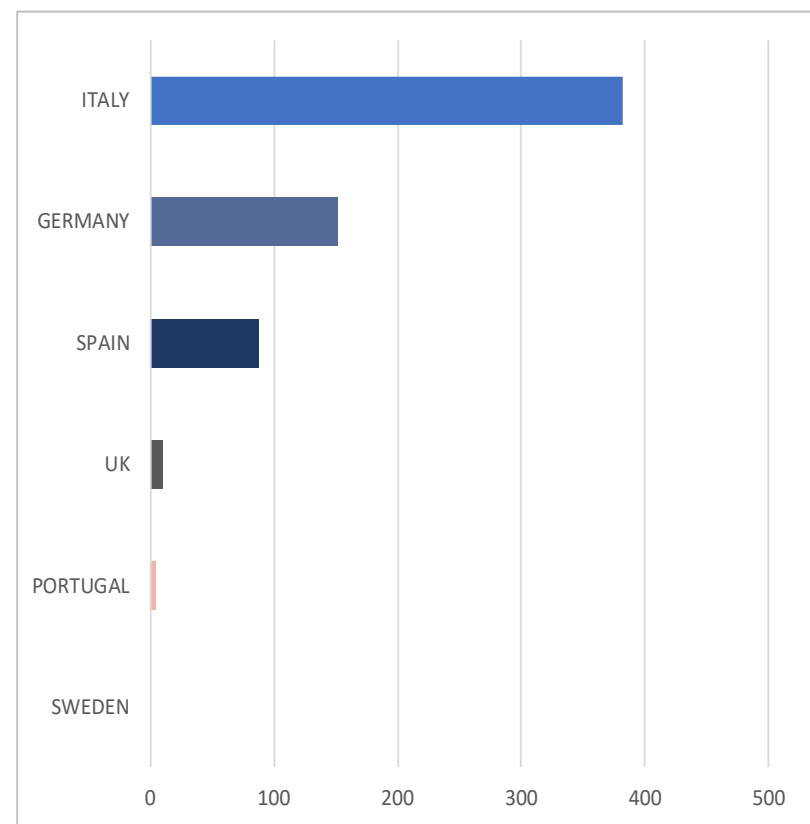

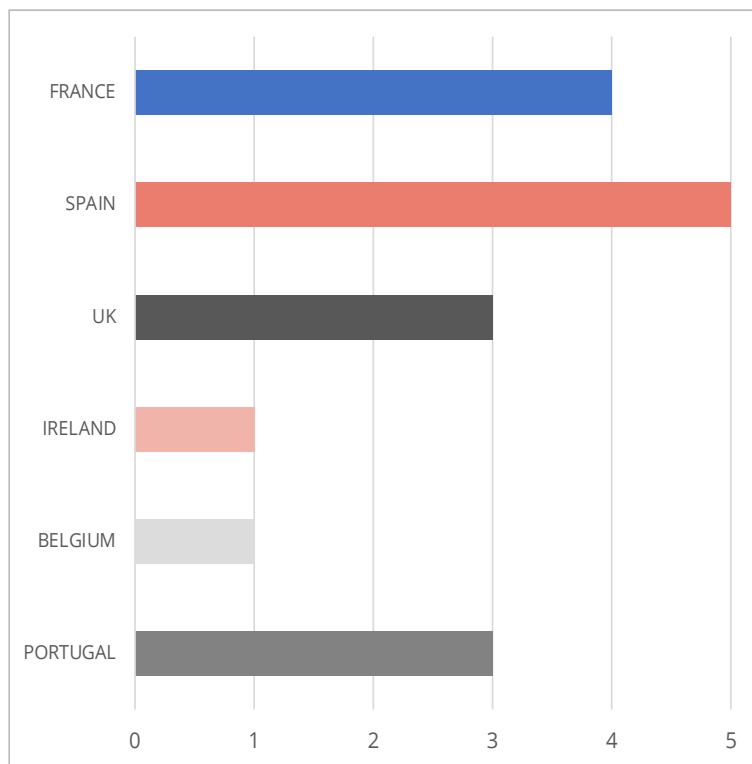

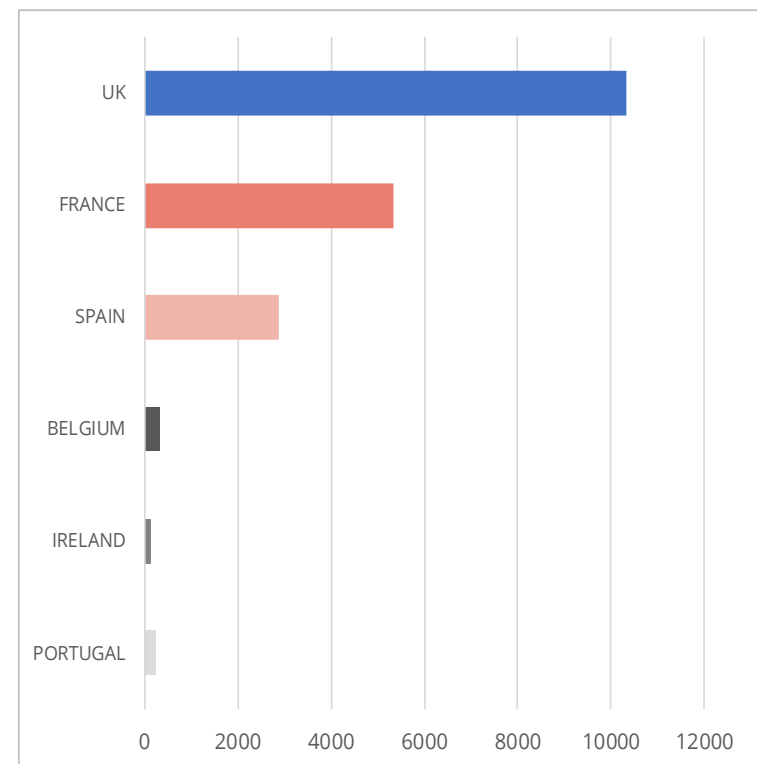

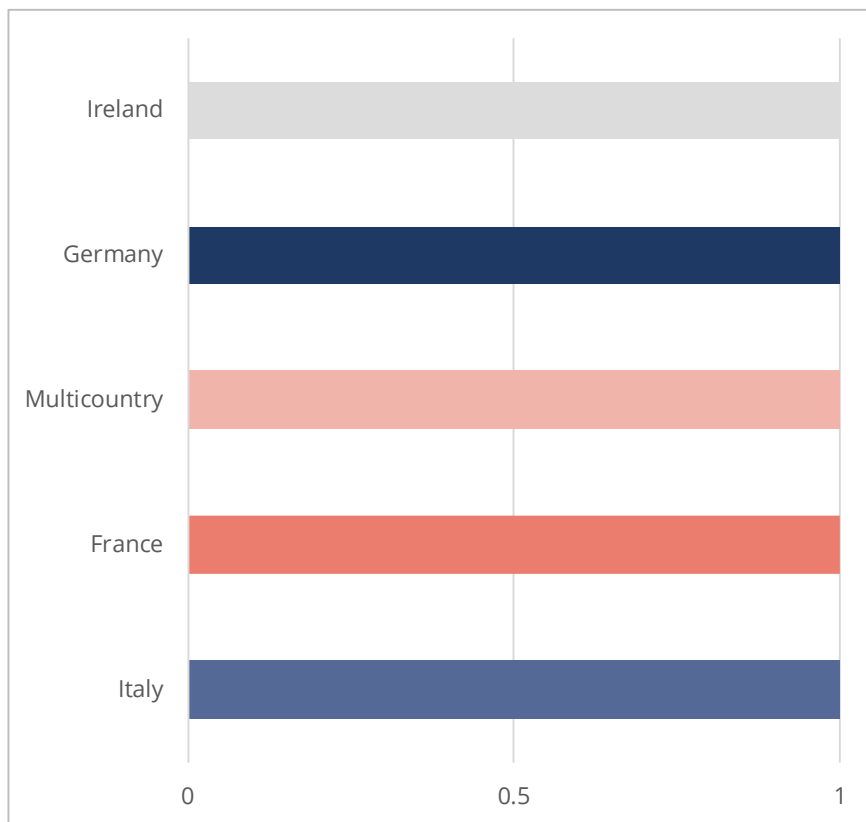

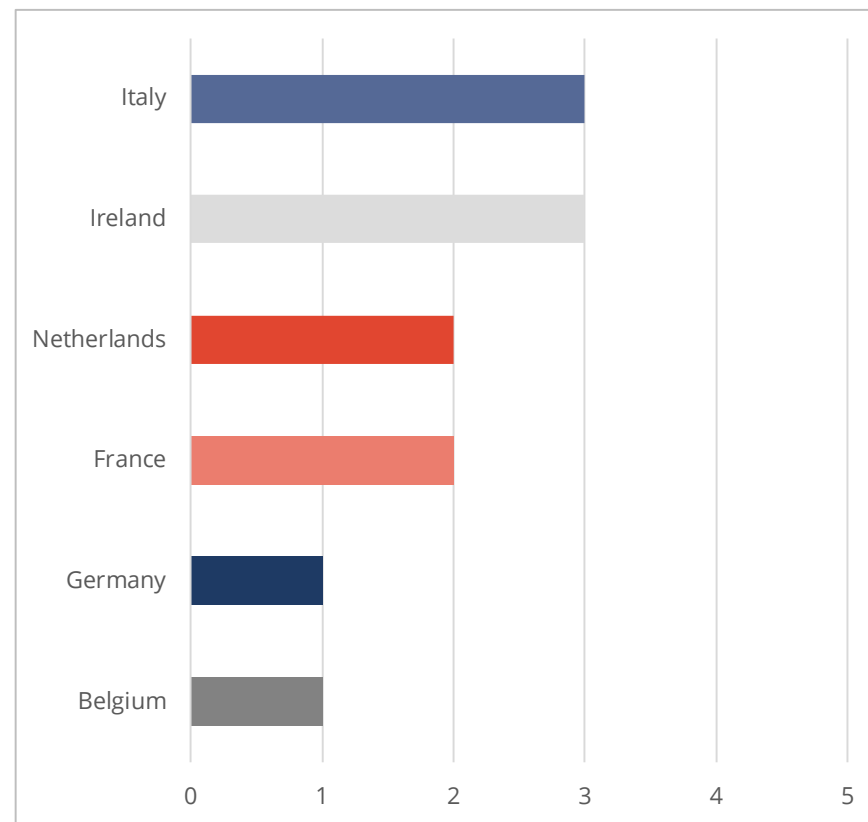
