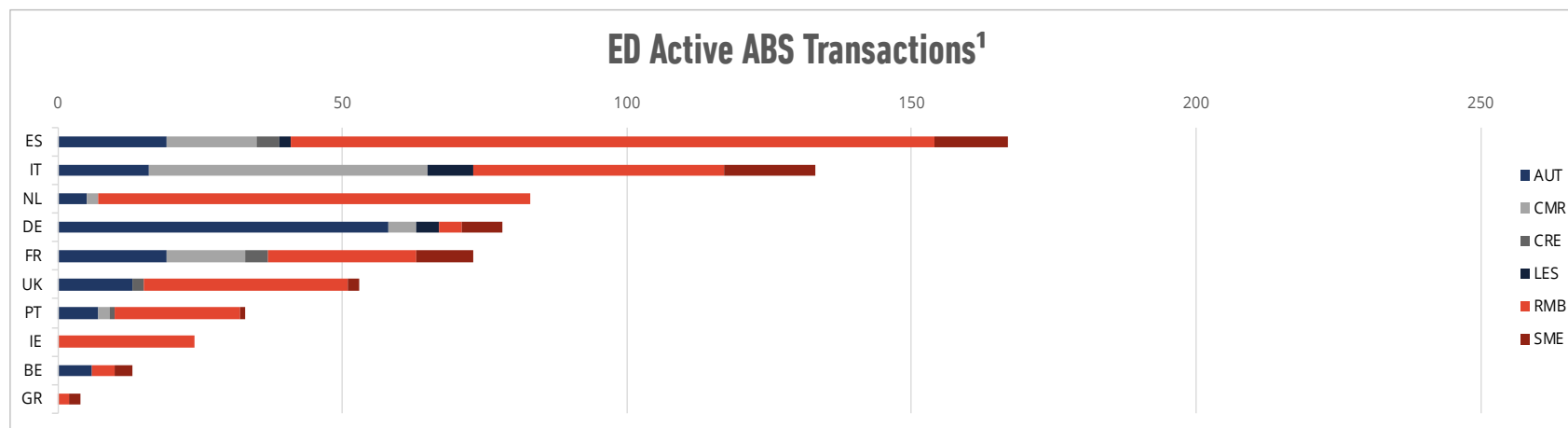
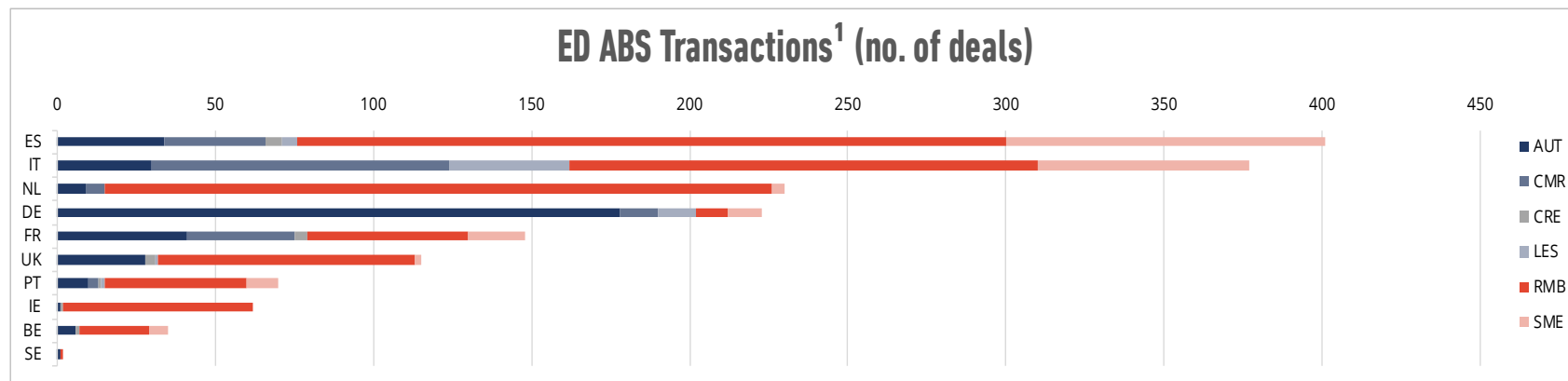


# DATASET COMPOSITION AS OF 31 DEC 2022

# DATASET COMPOSITION AS OF 31 DEC 2022

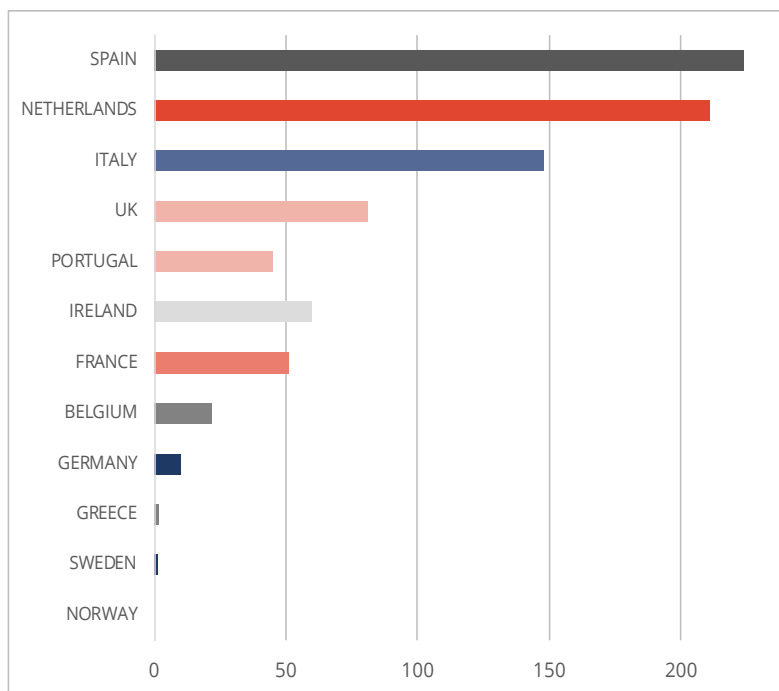

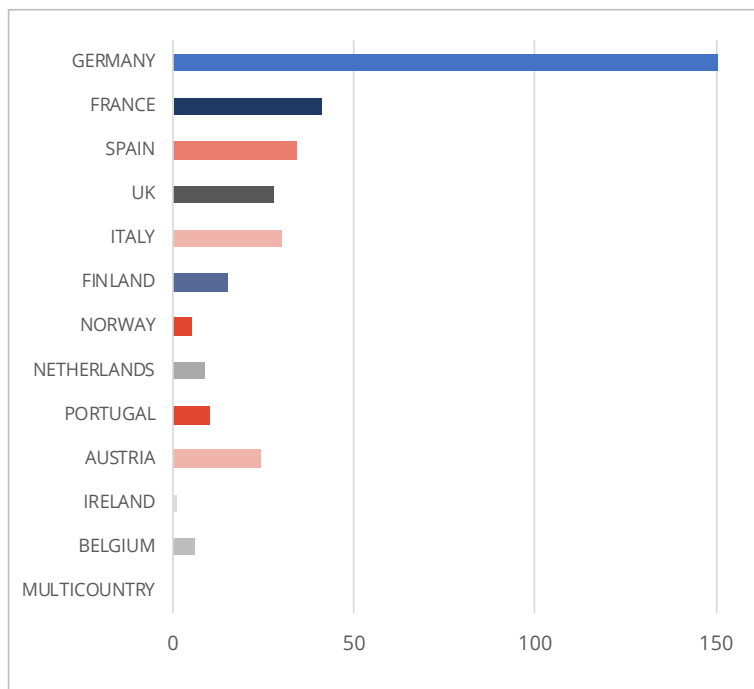

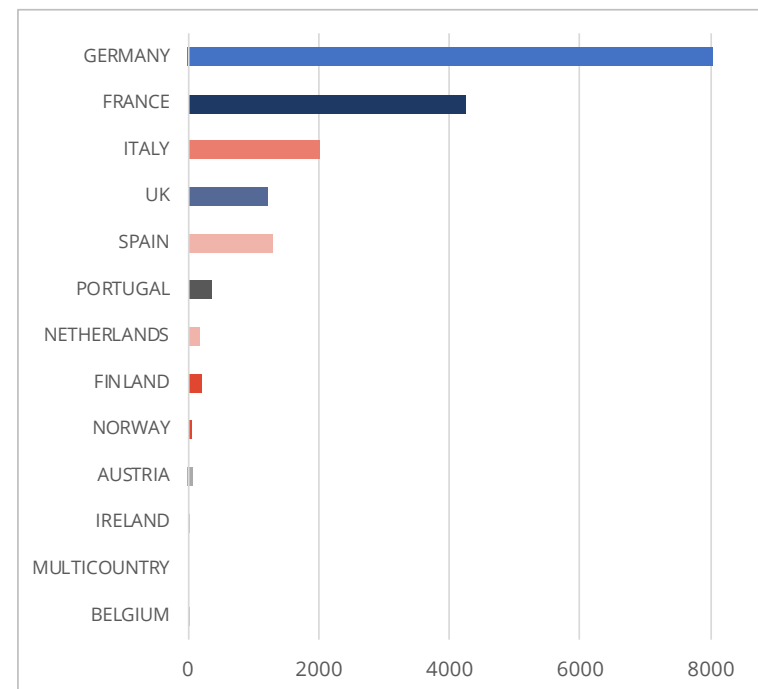

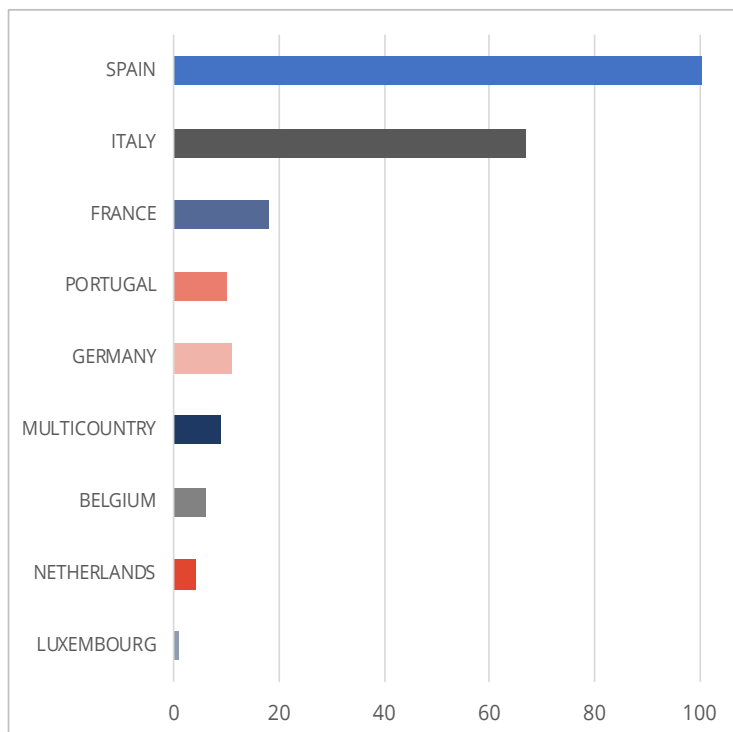

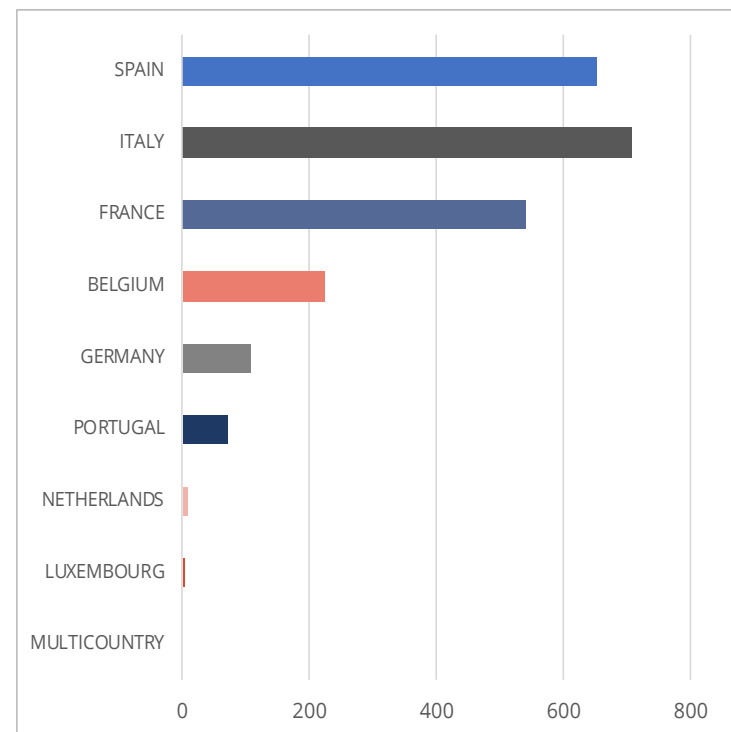

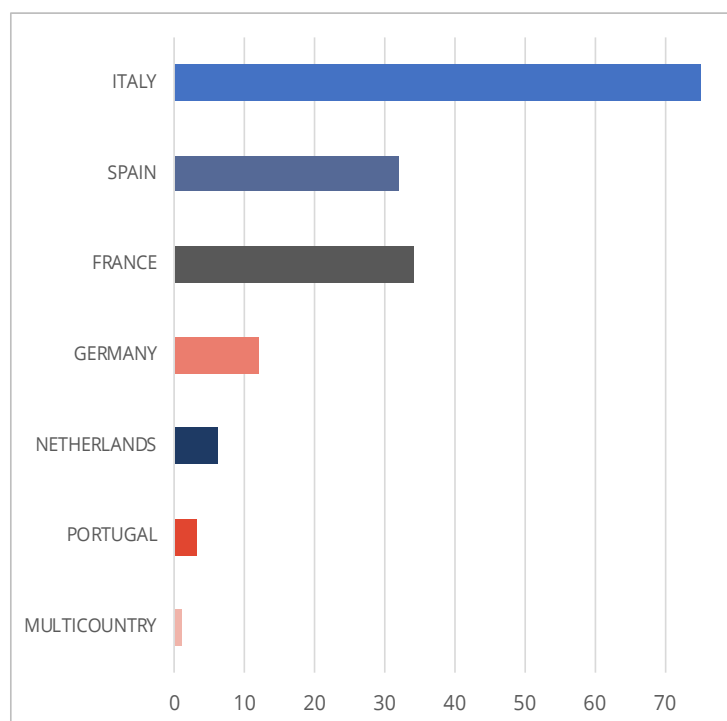

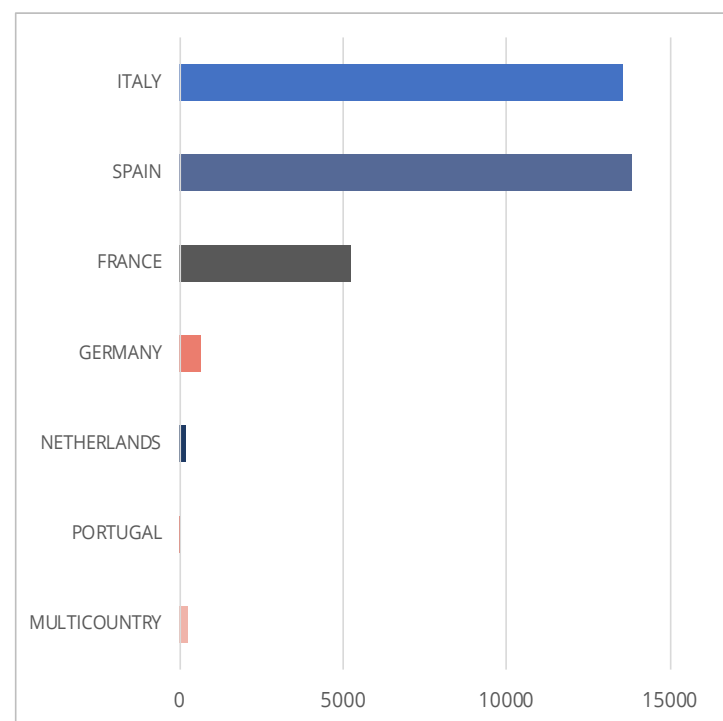

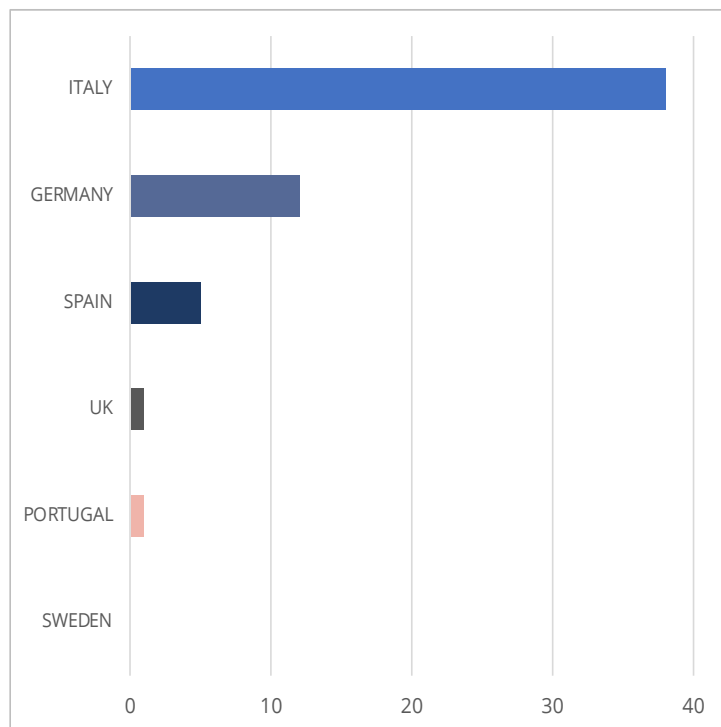

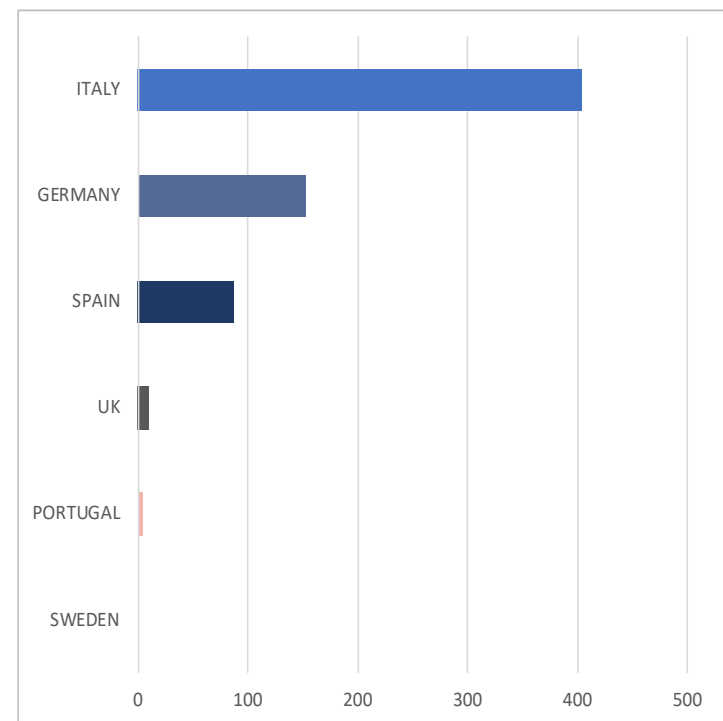

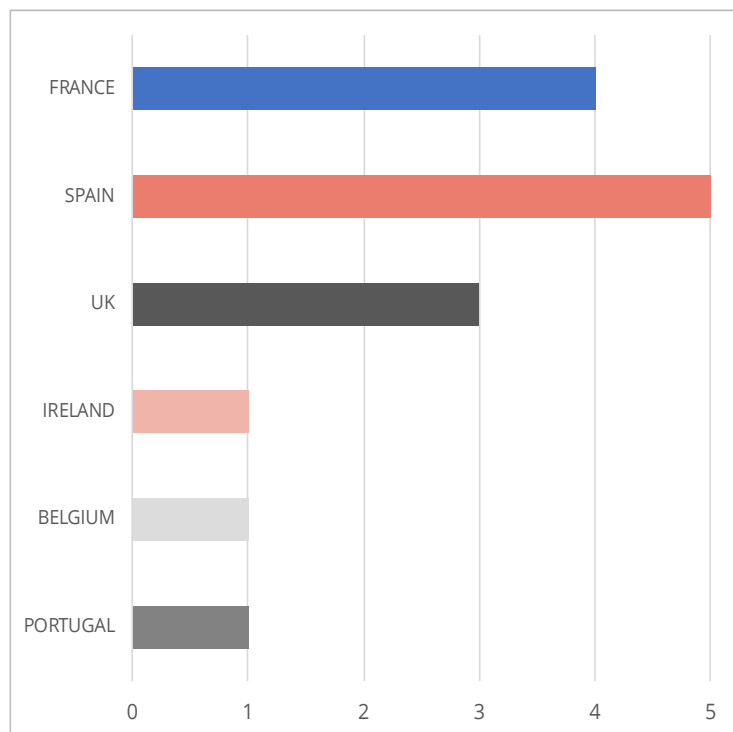

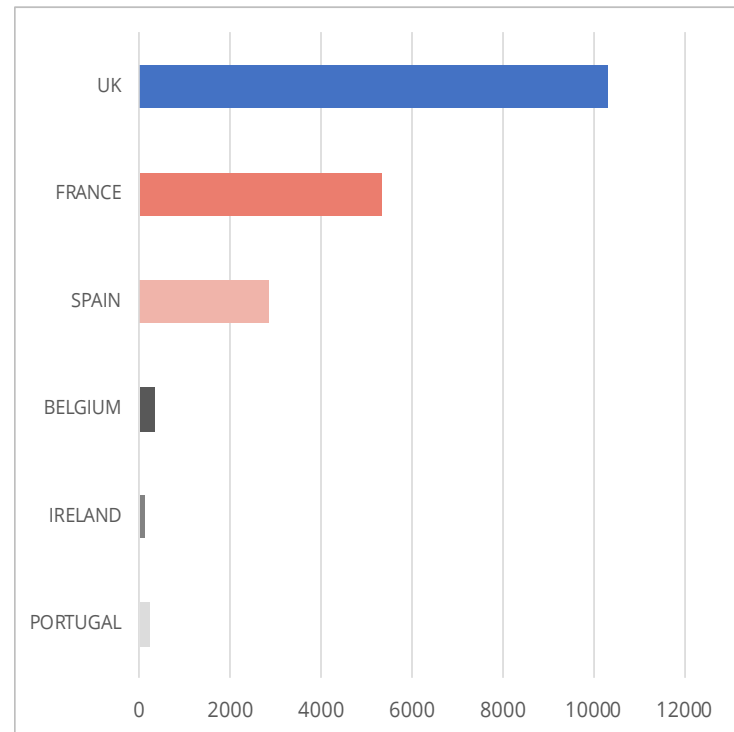

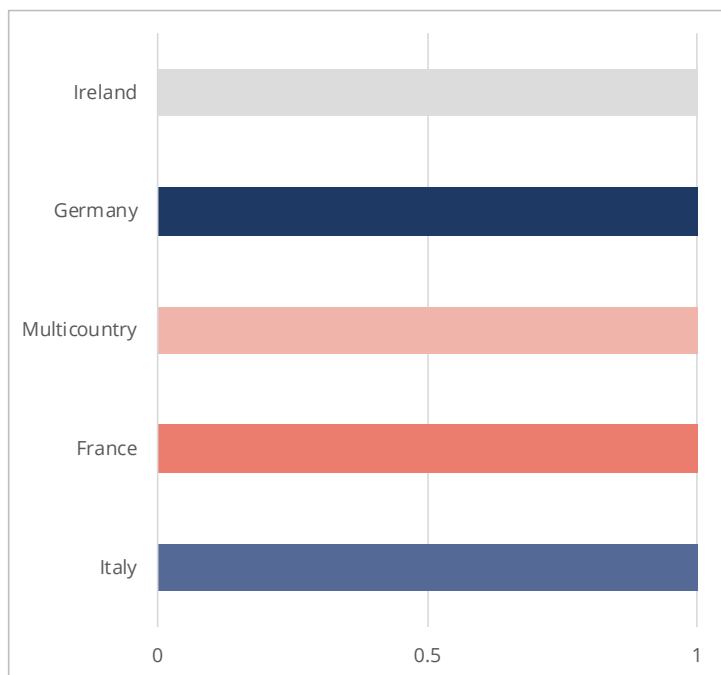

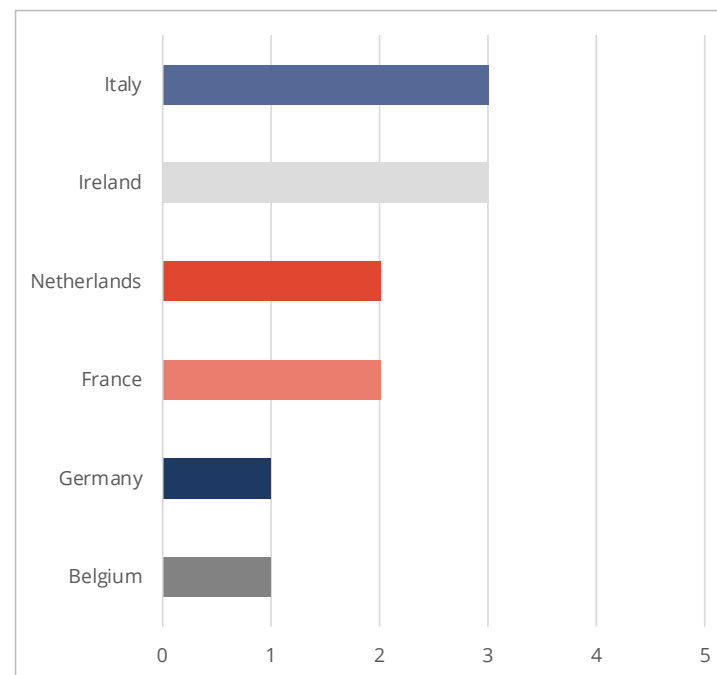
